

CASE STUDY: OHIO

Inspectors help gas pipeline operator mitigate delays, hit marks

The client needed an inspection program for gas transmission and distribution projects to ensure compliance with company, state, and federal regulations. Paxon onboarded more than 45 credentialed inspectors within 30 days. Since 2022, the program has operated with a \$25 million annual budget, achieved a 20% diversity spend, and maintained zero lost days and zero recordable incidents.

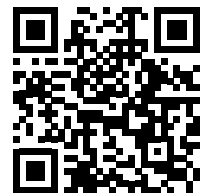
